Co-operation Housing is proud to announce that we have entered into a collaboration with the City of Fremantle that has seen us take on management of an affordable housing complex for seniors, owned by the City of Fremantle, with the long-term goal of embedding some of the international principles of co-operation into its management.

Consistent with our overall ethos of supporting successful residential communities, based on the housing co-operative model, that are affordable to people on low to moderate incomes, we have already begun to invite the residents to actively participate in making decisions that will affect them, affording them a greater sense of ownership and empowerment about their own homes and community.

The complex comprises 11 one-bedroom units, two of which were vacant when we took on management. We have since had them refurbished and welcomed two lovely new residents who we hope will be very happy in their new homes.

One of the new residents has already been featured in a good-news story in the *Fremantle Gazette*, helping us to spread the word to the wider community.

Representatives from Victoria's Common Equity Housing Limited, United Housing Co-op and South East Housing Co-operative, NSW's Common Equity and WA's own Co-operation Housing and FOHCOL discussed the key issues facing housing co-operatives nationally, with the intention of addressing these collectively where possible.
